# Rules for food distribution of Barsbüttel Food Bank <u>Admittance only with Food Bank ID Card</u>

Place of distribution:	At Jugendzentrum (youth centre) AKKU, Am Akku 1; Barsbüttel
Opening hours:	Every Wednesday from 12:00 to 13:30
Distribution sequence >> Sched	Food shall be distributed according to the specified distribution sequence and time of the ID Card numbers. <b>To be late</b> means: either <b>no food or wait until the end of the distribution</b> ules of the distribution sequences will be laid-out every Quarter <<
<u>Cost of collection</u>	<ul> <li>Every customer shall pay 2.00 € upon entrance to the distribution.</li> <li>the following money will be accepted only</li> <li>coins of 2.00 - 1.00 - 0.50 - 0.20 - 0.10 € or</li> <li>small notes of 20.00 - 10.00 or 5.00 €</li> </ul>
Additional rules:	The Food Bank ID Card shall be worn visibly at the distribution There is <b>strictly no self-service</b> at the distribution counters! The food available will be handed out by the personnel based on the number of persons stated on the Food Bank ID Card. - special requests will be considered according to the supply - - food handed over cannot be taken back -
Registration:	The participation and the payment of the customers will be recorded.

## **Registration at the Food Bank**

#### **Time of Registration**

every Wednesday from 11:30 to 11:50

**Who is eligible?** People in need having their place of residence in Barsbüttel and their relatives (spouse/life partner and their minor children).

#### Which documents shall be presented?

- National ID Card or Passport
- Proof of income, which shows the neediness\* of the applicant
  - \* attestation of the social welfare department (Sozialamt) or Jobcenter \* Rentenbescheid.

#### Which data will be recorded?

- Family name, given name, date of birth, address and nationality
- Given name of partner (if relevant, deviating family name), date of birth
- Name(s) of child(ren), sex and date of birth
- Mark for "no pork" / "no gelantine"
- Data of the proof of income supplied (at the first registration / thereafter check upon request).
- <u>**Customer number**</u> Upon registration every customer receives the Food Bank ID Card with his customer number, relevant for the distribution sequence.

#### Suspension from the distribution:

In case of incidents the Food Bank Board may suspend customers from the distribution for up to 4 distributions dates, in severe cases customers may be completely excluded from the distribution.

#### Cancellation of the eligibility:

After 6 months of unattendence the customer number will be erased. A resumption may be applied according to the registration rules.

#### Loss of the Food Bank ID Card

The loss of the Food Bank ID Card shall be reported upon entrance. A fee of  $2,00 \in$  shall be payed for the **replacement card** (cost of material).
